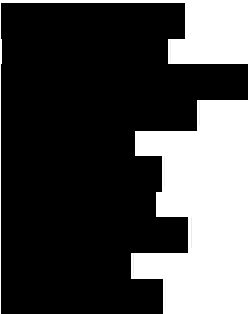
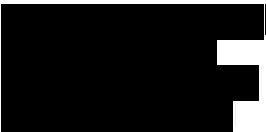
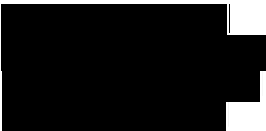

<p>(b) Applications shall not disrupt or disable activated features of other products that are identified as accessibility features, where those features are developed and documented according to industry standards. <p>(d) Sufficient information about a user interface element including the identity, operation and state of the element shall be available to Assistive Technology. <p><b>2. At least one mode of operation and information retrieval that:</b></p>	
a.	<p>For blind users, does not require vision.</p> 
b.	<p>For vision impaired users, does not require visual acuity greater than 20/70.</p> 
c.	<p>For deaf users, does not require hearing.</p> 
d.	<p>For hearing impaired users, does not require enhanced auditory capability.</p> 
e.	<p>For users with no speech capability or with impaired speech, does not require user speech.</p> 
f.	<p>For users without fine motor control or simultaneous action capability, does not require fine motor control or simultaneous action and is operable without limited reach and strength.</p> 

The relevant provisions of Subpart D, Information, Documentation, and Support, paragraph **1194.41**, shall apply to the services identified in paragraphs C.6.4.1, above.

**§ 1194.41 Information, documentation, and support.**

(a) Product support documentation provided to end-users shall be made available in alternate formats upon request, at no additional charge.
