To Whom It May Concern:

Funds managed by Apollo Global Management, Inc. (together with its consolidated subsidiaries, including Connect Holding LLC, "Apollo") and Lumen Technologies Services Group, LLC ("Lumen") have entered into a definitive agreement where Apollo will acquire certain Lumen ILEC assets and place all such assets under Customer, one of Apollo's operating companies (the "Acquisition Transaction"). The Acquisition Transaction is subject to customary closing conditions, including regulatory approvals, and is expected to close on or about October 1, 2022 (the "Closing Date").
