

# Edge Bare Metal

## Privacy Data Sheet

This Privacy Data Sheet describes the Processing of Personal Information by Edge Bare Metal (the "Service"). Edge Bare Metal provides dedicated, on-demand, and pay-as-you-go server hardware hosted in distributed locations. Dedicated physical servers offer maximum performance and secure single tenancy to isolate and protect data with User-defined firewall policies, fully-encrypted local storage, and Lumen's high-performance network. Run apps and data via edge market nodes designed for 5ms or better latency over our global fiber network and turn bare metal servers on and off as needed with pay-as-you-go flexibility. Lumen provides the Service directly for use by Customer and Customer's End Users. Lumen may Process Personal Information Customers provide regarding Customer and End Users in the course of providing the Service.

### Types of End User Personal Information

End User Personal Information may include (depending upon Customer configurations):

- Any Customer Information remaining on Lumen equipment at the termination of Service (Customer is responsible for deletion prior to terminating Service; Lumen will perform a secure deletion upon Customer's termination of the Service)

### Purpose of Processing

Necessary to securely terminate the Service (if Customer has not already deleted Customer Information)

### Authorized Personnel with Access

- **Lumen:** Securely terminate service
- **Customer:** Through Lumen Control Center and/or Service portals with access limited to only that Customer's End User Information
- **Equus:** Deleting data (only if there were an equipment failure and Lumen's efforts to securely delete the data failed)
- **Dell:** Deleting data (only if there were an equipment failure and Lumen's efforts to securely delete the data failed)

### Retention Periods

#### Lumen:

- Any Customer Information remaining on the Lumen equipment will be deleted within one (1) hour of Customer's termination of the Service

### Transfer of Personal Information Across Borders

Lumen uses Standard Contractual Clauses to transfer Personal Information outside the European Economic Area to countries that have not received a determination of adequacy from the European Commission.
