RE: End-of-life notification for the Lumen® Mesh Delivery, CDN Load Balancer and Mesh Delivery for Enterprise services / Notice of Termination, effective September 30, 2023.

Dear Customer,

We regret to inform you that Lumen has begun the End-Of-Life (EOL) process for the Mesh Delivery, CDN Load Balancer, and Mesh Delivery for Enterprise (eCDN) services (collectively, "the Services"). Lumen will no longer provide the Services after September 30, 2023 (the "End of Life Date"). Our records indicate that Lumen provides one or more of the Services to you under current or expired contract terms.

We understand that this announcement may be unwelcome news to you and your organization. Lumen is providing this notice now so that you have enough time to transition off of the platform without incurring any applicable early termination fees or migrate to a similar Lumen service. These include Lumen CDN Delivery in place of CDN Mesh Delivery as well as eCDN, and Lumen Intelligent Traffic Manager in place of CDN Load Balancer. We are committed to helping you with this transition to minimize disruption to your streaming operations.

As of the End of Life Date, you will no longer have access to your dashboard account and the associated data. All requests for data extracts beyond what is accessible in your dashboard must be made in writing to me before August 15, 2023 ("Deadline to Request Data") and are subject to Lumen approval. All data extracts will be automatically deleted by Lumen as of the End of Life Date.
