

14. DESCRIPTION OF AMENDMENT/MODIFICATION (Organized by UCF section headings, including solicitation/contract subject matter where feasible.)

The WITS 3 contract is hereby modified to extend the contract period of performance from November 8, 2015 through May 30, 2020. This modification contract extension is inclusive of a base period and two option periods. Option period 1 and 2 may or may not be executed at the discretion of the government. Level 3's proposal L10313.01, dated July 30, 2015, and final proposal revision dated August 25, 2015, are hereby incorporated. The contractor shall update all applicable pricing tables, and shall update its management system with fifteen (15) days after the effective date (See Block 16C) of this contract modification extension. - This WITS 3 contract modification extension is hereby executed and the period of performance is: four (4) years and six (6) months from the effective date of November 08, 2015, and not to exceed May 30, 2020; it is inclusive of a base period and two option periods as shown below:
  - November 8, 2015 – November 7, 2018 WITS 3 Extension Base Period
