Level 3 recognizes the business and technical challenges that come with the transition of WITS 3 services from an incumbent to another contractor. Our tested approach is to mitigate problems with diligent planning, excellent communication and winning collaboration across all parties throughout the planning and execution of the transition activities. We will seek the support of GSA and end user agencies in establishing sources of motivation for the incumbent to provide good faith effort towards a timely and effective transition. In addition to these partnerships, diligent development, execution of a robust transition plan, and planning for contingencies, will allow us to continue our demonstrated effectiveness in moving customers onto the Level 3 world-class network.



Our Initial Transition Management Plan (TMP) includes a plan transitioning 50% of the WITS 3 footprint as defined in Section J.3 of the RFP. We will submit a final detailed Transition Plan to GSA for approval that will include the project management of all transition activities for all services, provisioned and non-provisioned, provided by Level 3.

This Initial TMP addresses our approach to and detailed task schedule for the proposed transition solution. Our plan addresses the following topics:

Section G.1.3—Provides a description of Level 3's interconnection agreements that will be used during the transition of services and features


